2. Filled in Google Form should be submitted by or before **27<sup>th</sup> February 2024 (Tuesday)** up to 5:00 pm.
3. Google Form submitted after the scheduled date and time i.e. **27<sup>th</sup> February 2024 (Tuesday)** up to 5:00 pm shall not be entertained and summarily rejected.
4. Only eligible candidates shall be accessed for the viva-voce on the date of Interview. The list of eligible shortlisted candidates and date for Interview will be displayed on CSIR-IIIM Website: [www.iiim.res.in](http://www.iiim.res.in) by evening on **29<sup>th</sup> February 2024 (Thursday)**
5. Eligible/shortlisted candidate shall attend the Online Interview through Video Conferencing on MS Teams.
6. The viva-voce in respect of eligible/shortlisted candidates shall be conducted online (through Video Conferencing on MS Teams). However, if a large number of candidates apply, the Screening Committee may re-visit the screening criteria and shortlist the candidates for Interview in proportion to the available vacancies
7. Candidate has the option to interact in English/Hindi before the Selection Committee.
8. The positions are purely temporary on contract basis and co-terminus with the respective Project.
